A candidate committee shall file a campaign finance report only during the four calendar quarters comprising the twelve-month period preceding the general election for the office for which the candidate is seeking election...The reporting period for a candidate committee's first campaign finance report of the election cycle shall include the entire election cycle to date. [A.R.S. § 16-927 (B)]
