If I am duly appointed as a Student Poll Worker, I will faithfully perform my duties to the best of my ability and according to the election laws of the State of Arizona. I understand that the job of Student Poll Worker requires me to attend an in-person training class, complete online training, to assist with setting up the Vote Center on the Monday prior to the election, and to work at the Vote Center on Election Day from 5:30 AM until all work at the Vote Center is completed. The polls close at 7:00 PM, typically work lasts until approximately 9:00 PM but may be later. I understand that I must be registered to vote in Yavapai County if I am age 18 by Election Day.

Requirements:

- High School student
- 16 or older by Election Day
- Registered to vote in Yavapai County ***IF*** 18 by Election Day

To Apply - Submit Your Application (see reverse):

- Must be signed by your parent/guardian & school principal
- Can be returned by email, mail, or dropped off (addresses below)
- We will contact you to discuss placement. Not all students who apply will be hired

Before the Election:

- Complete online training and in-person training
 - Online training is available about a month before the election
 - In-person training is 2 weeks before the election and last about 2 ½ hours
- Attend a set-up meeting to prepare your Vote Center
 - The day before the Election (Monday)
 - Between noon and 7:00 p.m. and lasts about 2 hours
- Notify your school in advance of all absences (training, setup & Election Day) related to being a Student Poll Worker

Election Day:

- Arrive by 5:30 a.m.
- Serve until 9:00 p.m. or later
- You can't leave the Vote Center & return, so bring enough food to last all day
- Serve as an Electronic Poll Book Clerk checking in voters, or in a variety of positions as assigned

Pay: \$135 per election (\$115 + \$10 for online training and \$10 for in-person training)
