### PROPOSITION 454

**OFFICIAL TITLE:** A MEASURE REFERRED TO THE PEOPLE BY THE PRESCOTT CITY COUNCIL RELATING TO A FRANCHISE AGREEMENT WITH UNS GAS, INC. FOR THE USE OF THE PUBLIC RIGHTS-OF-WAY IN THE CITY OF PRESCOTT, ARIZONA, FOR THE PURPOSE OF CONSTRUCTING, OPERATING, AND MAINTAINING ITS NATURAL GAS SYSTEM AND DISTRIBUTING NATURAL GAS.

**DESCRIPTIVE TITLE:** Consideration of a Franchise Agreement with UNS Gas, Inc. for a period of 25 years for the purpose of constructing, operating, and maintaining its natural gas system and distributing natural gas within the City.

A "YES" vote shall have the effect of approving a franchise agreement with UNS Gas, Inc. to use the City-owned public rights-of-way to construct, operate, and maintain its natural gas system and to distribute and sell natural gas within said City.

A "NO" vote shall have the effect of not approving a franchise agreement with UNS Gas, Inc. to use the City-owned public rights-of-way to construct, operate, and maintain its natural gas system and to distribute and sell natural gas within said City.

### QUESTION

Shall the District Board of Crown King Fire District, be authorized to sell and issue general obligation bonds of Crown King Fire District, in the aggregate principal amount of not to exceed \$1,000,000, to provide funds to construct, equip and furnish new fire stations, to renovate, improve or reconstruct existing fire stations, to acquire any interests in land necessary with respect to the foregoing, to acquire apparatus, water and rescue equipment, including ambulances and equipment related to any of the foregoing, to liquidate indebtedness previously incurred for such purposes and to pay all legal, engineering, architectural, accounting, financial consultant and other necessary costs in connection therewith; said general obligation bonds to bear interest at a rate not to exceed 12% per annum and to mature over a period of not to exceed 20 years from the date of their issuance and may be sold at prices that include premiums not greater than permitted by law?

### QUESTION

Shall the Governing Board of Mingus Union High School District No. 4 of Yavapai County, Arizona (the “District”), adopt a General Maintenance and Operation Budget that includes an amount that exceeds the revenue control limit specified by statute by 10% for fiscal year 2022/2023 and for six subsequent years as described below? The fiscal year 2022/2023 budget override authority represents an extension of the existing budget override authority which is scheduled to phase down by one-third for fiscal year 2023/2024, by another one-third for fiscal year 2024/2025, and terminate for fiscal year 2025/2026 if the voters do not approve the override.

The amount of the proposed continuation of the budget increase of the proposed budget over the alternate budget for fiscal year 2022/2023 is \$-0-. In fiscal years 2022/2023 through 2026/2027 the amount of the proposed increase will be 10% of the District’s revenue control limit in each of such years, as provided in Section 15-481(P) of the Arizona Revised Statutes. In fiscal years 2027/2028 and 2028/2029, the amount of the proposed increase will be 6.67% and 3.33%, respectively, of the District’s revenue control limit in each of such years, as provided in Section 15-481(P) of the Arizona Revised Statutes.

Any budget increase continuation authorized by this election shall be entirely funded by a levy of taxes on the taxable property in this school district for the year for which adopted and for six (6) subsequent years, shall not be realized from monies furnished by the state and shall not be subject to the limitation on taxes specified in Article IX, Section 18, Constitution of Arizona. Based on the current net assessed valuation used for secondary property tax purposes, to fund the proposed continuation of the increase in the school district’s budget would require an estimated continuation of a tax rate of \$0.25 per one hundred dollars of assessed valuation used for secondary property tax purposes and is in addition to the school district’s tax rate that will be levied to fund the school district’s revenue control limit allowed by law.
